This has reference to your application I.D. No. 6622-03/03/2022 seeking accreditation by National Board of Accreditation (NBA) to Diploma Engineering program offered by **Government Polytechnic, Berhampur, Ganjam, Orissa-760010.**

2. An Expert Team conducted onsite evaluation of the program from **06<sup>th</sup> to 08<sup>th</sup> December, 2024**. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
